- 4. A 14-day statement of health, certificate of veterinary inspection or a health certificate, required for all horses arriving from instate or outside the state of Florida. Health certificate: due at check-in
- 5. Trainer/Owner Health Declaration (New for 2024) Signed by an owner/trainer confirming that the horse has not experienced a fever exceeding 101.5 degrees or any disease in the 72 hours leading up to its arrival. Additionally, the horse must not have been exposed to or treated for an unexplained fever in the past 28 days and should have tested negative for any disease at least 30 days prior to arrival. If the horse has tested positive within the last six months for any infectious diseases, this information should also be disclosed. See Form at:
